WHEREAS, the Declaration of Condominium for Cappello II at Venetian Golf & River Club, A Condominium, was recorded on April 29, 2014. in Official Records Instrument Number 2014049436, public records of Sarasofa County, Florida, as has been or may be amended from time to time (collectively, 'Declaration'), and

WHEREAS, WCI is the Developer under the Dectaration ("Developer"), and

WHEREAS, based upon recent changes in the requirements of the Florida Fire Prevention Code, Developer has determined that certain provisions of the Declaration require revision in order to be consistent with such code; and

WHEREAS, Developer has not conveyed 100% of the Units to third parties as of the effective date hereof, and the threshold end date for the right to make special amendments has not yet occurred; and

NOW, THEREFORE, WCi, as Developer under the Declaration, hereby declares as follows

 The foregoing recitals are true and correct and are hereby incorporated herein as if fully set forth hereinafter.

 All defined terms herein shall have the same meaning as set forth in the Declaration, unless the context in this Special Amendment requires otherwise.

 Section 18.12 of the Declaration is hereby deleted in its entirety and is replaced with the following:

18.12 <u>Gnils and Other Similar Devices</u>. Use of barbecue grills shall only be allowed in areas designated as safe and appropriate by the Board. In accordance with the Flonda Fire Prevention Code (Fifth Edition), effective December 31, 2014, no hibachis, grills or other similar devices for cooking, heating or any other purpose shall be

used, kindled or stored on balconies, lanais, loggias, patios, and/or porches or any other Limited Common Element areas, or within 10 feet of any Building or other structure.

Except to the extent modified herein, the Declaration remains valid and in full force and 4. effect.

5. In the event of a conflict between the terms and provisions of the Declaration and this Special Amendment, the terms and provisions of this Special Amendment shall control.
